Dishman Hills Association would be eligible for a state grant if Initiative 90 becomes law, according to a Department of Game spokesperson. The initiative proposes 1/8 of 1% addition to the sales tax, which would add 1 cent to an \$8 purchase. Its purpose is to help the Department of Game better protect both game and nongame species.

### FIRST LANDPAYMENT MADE

Our September payment of \$6339.21 on the Dishman Hills addition has been made on schedule. Donations for July 1 - Sept. 15 of amounts of \$150 or less totaled \$4830.79. In addition we received two gifts totaling \$1250 and one of \$13,000. However an estimated \$4100 of the latter gift were designated to cover one year's bulletin printing and mailing expense and office expense. We do not know whether the remaining \$8900 and the \$1250 can be allotted for one year's payments or whether they must be stretched over five years, so we have to run scared. More pledges would be a big help in forecasting the situation.
